If you do not report the loss of your driving license immediately and apply for a replacement document, you are committing an administrative offence.</p> <p>If your name has changed, you do not have to have a new driving license issued. However, it may be useful to be in possession of an EU driving license with up-to-date information, especially when driving abroad. If you wish to change the name on your driving license, you will be issued with a new card driving license upon request.</p> |
