Volltext	You require a permit for the commercial transportation of passengers by bus or coach in occasional services.

	Occasional services include <ul> <li>Excursions</li> <li>Vacation trips</li> <li>Trips with rental buses</li> </ul> <li>If you wish to increase the number of vehicles or seats for your bus and coach company, you must apply for an extension of the permit from your competent licensing authority.</li>
Erforderliche Unterlagen	<ul> <li>Valid authorization for the occasional transport of buses and coaches</li> <li>Application for extension of the permit with details of the acquiring company and person: Surname and first name Place of residence and registered office for natural persons: Date of birth, place of birth Number of vehicles, vehicle type, capacity of the vehicles to be used</li> <li>Equity certificate, additional certificate if applicable, not older than 3 months</li> <li>Certificate in tax matters from the tax office, the municipality, the social security institutions and the employers' liability insurance association, not older than 3 months: from the company the legal representative the person or transport manager appointed to manage the business</li> <li>Certificate of good conduct for submission to the authorities</li> <li>Extract from the central trade register for companies</li> <li>Extract from the driving aptitude register (FAER)</li> <li>Vehicle list</li> <li>Proof of liability insurance for buses and coaches including risk identification number (WKZ)</li> <li>Business registration</li> </ul>
Voraussetzungen	<ul> <li>You are already in possession of a bus and coach license.</li> <li>You can guarantee the financial capacity of the company.</li> <li>You or the person appointed to manage the business are reliable.</li> <li>You or the person appointed to manage the business are professionally qualified.</li> <li>You and the entrepreneurs commissioned by you to</li> </ul>

Verfahrensablauf	<ul> <li>Submit an application for an extension of your existing permit to the competent authority.</li> <li>Include all necessary documentation supporting the extension and explaining its impact on the current permit.</li> <li>The authority will assess the additional requirements and review the existing financial and technical basis.</li> <li>If approved, the extension of the permit will be granted and you will be notified in writing.</li> </ul>
Bearbeitungsdauer	A decision on your application will be made within 3 months. Processing can be extended by 3 months if necessary.
Frist	Period of validity 10 years
