Teaser	Would you like to continue your bus company as an occasional service? Then you must apply for the necessary permit from the licensing authority responsible for you.

Volltext	You require a permit for the commercial transportation of passengers by bus or coach in occasional services. Occasional services include • Excursions • Vacation trips • Trips with rental buses The permit is limited to a maximum of 10 years. Before your temporary permit expires, you can submit a corresponding application for reissue to your competent licensing authority. On the basis of the new, again temporary permit, you can continue your bus and coach operation seamlessly.
Erforderliche Unterlagen	<ul> <li>Current and expiring permit</li> <li>Application for reissue of the bus and coach permit for occasional services with details of: Surname and first name Place of residence and place of business for natural persons: Date of birth, place of birth Number of vehicles, vehicle type, capacity of the vehicles to be used</li> <li>Certificates of employment or examination certificates regarding your professional suitability</li> <li>Equity certificate, additional certificate if applicable, not older than 3 months</li> <li>Certificate in tax matters from the tax office, the municipality, the social security institutions and the employers' liability insurance association, not older than 3 months: from the company the legal representative the person appointed to manage the business or traffic management</li> <li>Certificate of good conduct</li> <li>Extract from the driving aptitude register (FAER)</li> <li>Vehicle list</li> <li>Proof of liability insurance for buses and coaches including risk identification number (WKZ)</li> <li>Business registration</li> </ul>
