Volltext	Anyone who trains persons who wish to acquire a license to drive motor vehicles(learner drivers) requires a driving instructor's license. The driving instructor license is issued onBE category and additionally in categories A, CE and DE. Thedriving instructor's license may only be used together with the driving instructor's license or as part of anemployment or training relationship with the owner of a driving school.of a driving school. If several classrooms are operated, a branch office permit must be applied for each additional room.must be applied for. You must apply in person. Representationis not possible.
Erforderliche Unterlagen	If you wish to apply for a driving school license, you must submit a written application to thecompetent licensing authority in writing, stating the name and address of thename and address of the future driving school and for which category or categories of motor vehicles you wish to acquire the driving school license. The application must also include application must also include -Identity card or passport with registration certificate -an officially certified copy or photocopy of the driving instructor's license -Documents relating to the activity as a driving

- a declaration as to whether a driving school license has already been issued and by which authorityhas already been issued
- a true-to-scale plan of the classrooms with details of yourequipment

- a list of the number and type of instruction vehicles

You must also submit a certificate of good conduct of document typeOH for submission to the licensing authority in accordance with the provisions of theFederal Central Register Act.

Voraussetzungen

Driving school is a term for a predominantly private school for theacquisition of theoretical and practical knowledge for driving motor vehicles.

Driving instructors are state-recognized teachers under the Driving Instructors Act (FahrlG) and itsand its regulations. They train their pupilsthe majority of whom are people who wish to acquire a license to drive motor vehiclesdriving a motor vehicle (learner drivers), in accordance with the requirements of thethe requirements of the learner driver training regulations in theory and practice. Thetraining may only take place in a driving school. The driving school must meet certain criteria. In the classrooms during theoretical lessonsteaching aids must be available in the classrooms during the theoretical visualization must be available. The details of the teaching aids prescribed in accordance with § 11 Para. 1 No. 6 FahrlG and§ 4 FahrlGDV can be found in the guideline on the equipment of driving schools with teaching aids.driving schools with teaching aids, which was published in the Verkehrsblattpublished in the Verkehrsblatt:

Kosten

The driving school permit, including the permit certificate, is issued for a fee. In accordance withfee number 302.3, the following fees are set:

Issuance of the driving school permit:

- natural person: 102.00 euros
- Legal entity: 153.00 euros

Issue of branch office permit: 84.40 euros

Extension of driving school permit: 56.20 euros

Extension of branch office permit: 40,90 Euro

The same appliesapplies to the issue of a driving license for temporary and occasional learnerlearner driver training, which in accordance with § 2a Para. 3 FahrlG can be made dependent on a priora prior aptitude test if there are significant differences between the professionalbetween the applicant's professional qualifications and the training and examination required in Germany.training and examination required in Germany. More detailed requirements for the content and content and timing of the adaptation period and the conduct of the aptitude testthe Federal Ministry of Transport and Digital Infrastructure has laid down in thein the Implementing Ordinance to the Driving Instructors Act. According to thisthe applicant must complete written exercises during the maximum three-year adaptationwritten exercises as well as theoretical and practical trial lessons during theand practical trial lessons. The subject of the adaptation period is the special features of German road traffic law and the German road traffic conditions and German driving instructor law. The adaptation course is organized by the driving instructors recognized under § 22of the Driving Instructors Act. Thecourse can be replaced by successful participation in an aptitude test.aptitude test. The aptitude test consists of a writtenwritten and oral examination as well as theoretical and practical driving lessons.practical driving lessons. The Professional Qualifications Assessment Act does not applywith the exception of § 17.
