Teaser	If you wish to change the details of your resident parking permit for a specific zone, you must apply to the relevant authority for the changes.
Volltext	If you need to change personal details such as address or vehicle details on your resident parking permit, which is valid for a specific zone, it is necessary to make the changes at the relevant road traffic authority in your place of residence. This concerns information about your vehicle or details of your home address so that the validity of the permit for the specifically designated zone is maintained. Make sure you make any changes in good time so that you can continue to benefit from the parking permits.
Erforderliche Unterlagen	• Application to change the data of the resident parking permit • Current proof of identity (e.g. identity card or passport) • Power of attorney • If applying through a representative • Changed vehicle registration certificate in case of change of vehicle data • Current registration certificate in the event of a change of address
Voraussetzungen	• You have a resident parking permit. • The affected vehicle must still be registered to you or used by you. • The new data must be up-to-date and correct, e.g. the new place of residence in the affected resident parking area.

Verfahrensablauf	• Apply to the relevant road traffic authority to change the data on the resident parking permit. • Submit the necessary documents to update the data. • The authority will check your change request. • You will receive confirmation of the change and possibly a new parking permit if necessary.

Hinweise	The resident parking permit does not guarantee a fixed parking space. The parking permit can be valid either only at certain times or around the clock.
