Teaser	If your resident parking permit is damaged or lost, you can apply for a replacement from the relevant authority.
Volltext	If your resident parking permit, which is valid for a specific zone, is lost or damaged, you can apply for a replacement from the road traffic authority in your place of residence. The replacement is necessary so that you can continue to use the parking facilities provided for your permanently used vehicle. When applying for the replacement permit, make sure you provide the relevant information and evidence to gain quick access to the required parking permits in your area.

Hinweise	The resident parking permit does not guarantee a fixed parking space. The parking permit can be valid either only at certain times or around the clock.
Rechtsbehelf	• Objection • Action before the administrative court
Kurztext	• The resident parking permit allows you to park in specially designated residential zones with high parking pressure. • Replacement is possible if the permit is lost or damaged.
