Teaser	The register of cooperatives is public. Anyone is permitted to inspect the register of cooperatives kept by the register court and the documents submitted for information purposes.
Volltext	You can view the register of cooperatives online via the "Joint register portal of the federal states". Here you will find information on the cooperatives entered in the register of cooperatives. Cooperatives are companies with an unlimited number of members whose purpose is to promote the acquisition or business of their members or their social or cultural interests through joint business operations (Section 1 of the Cooperatives Act - GenG).
Erforderliche Unterlagen	No documents are required.
Voraussetzungen	The register of cooperatives is public and can be viewed by anyone.
Kosten	There is no charge for inspecting the register of cooperatives or downloading an electronic copy. Only the issuing of copies or printouts is subject to a fee.
Verfahrensablauf	Joint register portal of the federal states: • Call up the joint register portal of the federal states. • Click on either "Normal search" or "Advanced search" in the menu and enter the relevant keywords and data. • Click on "Search". • The entries you are looking for will now be displayed
