	385.9). In the event of rejection: If an application to carry out an official act is withdrawn before it is completed, up to 75 percent of the full fee is payable, depending on the expenses already incurred (Section 9 (2) SaarlGebG).
Verfahrensablauf	1. You submit the application. 2. After your application has been reviewed, you will receive a fee notice. 3. Once you have paid the fee, the notification will be sent to you.

Frist	No deadlines need to be observed. However, permission must be granted before the substitution can begin. It is therefore advisable to submit the necessary application as early as possible.
