Teaser	<p>If you are in a social emergency, you can take advantage of advice on help to overcome particular social difficulties. However, this social emergency must go beyond the general risks of life and involve social exclusion.</p>
Volltext	<p>If you have particular social difficulties, you can advice on the help available to overcome these difficulties. As part of this counseling, the necessary requirements for requirements for the assistance can be clarified. Assistance to overcome particular social difficulties is a subordinate benefit. You will therefore also be informed about other, priority benefits that must be taken first. If you meet the following conditions, you may be eligible for assistance to overcome particular social difficulties may be granted:</p> <ul style="list-style-type: none"> <li>• Special living conditions exist in the case of lack of or inadequate housing unsecured economic livelihood living conditions characterized by violence release from a closed institution comparable disadvantageous circumstances</li> <li>• Social difficulties exist if life in the community is significantly restricted by the exclusionary behavior of the person seeking help or a third party, in particular in connection with maintaining or obtaining housing, obtaining or securing a job, family or other social relationships or delinquency</li> </ul>

Should a review reveal that you fulfill these requirements and no other benefits are possible, you can, for example, receive the following benefits:

- Advice and personal support, also for relatives
- Measures for obtaining and maintenance of a homehousing
- Assistance in obtaining and securing a job
- Assistance with school- or vocational training
- money- and benefits in kind are possible in individual cases, e.g. health insurance contributions, clothing allowance or pocket money for inpatient accommodation

**Erforderliche Unterlagen**

You must submit the documents or evidence that the authority that decides on the benefits deems necessary for this purpose at its due discretion In individual cases, the social welfare office may therefore request these necessary documents.

**Voraussetzungen**

You do not have to fulfill any requirements to receive the first consultation. to receive initial advice. In order to receive further help at a later date, individual decisions are necessary. decisions are necessary.

**Kosten**

Cost type: Free of charge

**Verfahrensablauf**

- In order to receive advice on help to overcome particular social difficulties, a corresponding contact request must be made.
- The specific support options can be discussed during the consultation.
- Possible priority benefits can also be discussed here.
- Possible priority assistance includes Assistance with health, assistance with care or assistance in other life situations, benefits under SGB II (citizen's allowance, basic income support for jobseekers), SGB VIII (child and youth welfare) and SGB IX (Rehabilitation and participation of people with disabilities). Whether the requirements for assistance to overcome particular social difficulties are met can be discussed during the consultation.
- In Saarland, decisions are made by the locally responsible administrative districts, the Saarbrücken Regional Association and the state capital Saarbrücken.

## Sachverhalt

However, individual items of evidence may require written form.

Informal application possible: Yes. However, it is advisable to use the forms provided, as these also serve to simplify and speed up the procedure.

Personal appearance necessary: As a rule, yes, as an identity check must also be carried out before benefits are granted. Applicants should also appear in person at the request of the responsible benefit provider for an oral discussion of the application or to take other measures necessary for the decision on the benefit.
