Teaser	If your child was stillborn and it is a miscarriage, you can report the birth to the registry office in whose jurisdiction the miscarriage occurred. The registry office will issue a certificate on request.
Volltext	<p>The competent registry office will issue a certificate of notification of miscarriage on request.</p> <p>A miscarriage is defined as a foetus that showed no signs of life (heartbeat, pulsating umbilical cord, pulmonary respiration) when it was separated from the womb, weighed less than 500 grams and did not reach 24 weeks of pregnancy.</p> <p>The registry office can issue a certificate of notification of miscarriage to the notifier on request.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• A certificate of miscarriage issued by a doctor, midwife or obstetrician</li> <li>• An identity card, passport or other recognized passport replacement document of the parents</li> <li>• An indication of the intended surname and first name of the child</li> <li>• Mother's passport</li> <li>• Certificate of burial of the miscarriage, if applicable</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• There was a miscarriage, which was reported to the relevant registry office with the necessary documents.</li> <li>• You can only register if you would have been entitled to custody of the child if it had been born alive, i.e. if you were married to each other at the time of the birth or if you were unmarried parents and made a joint declaration of custody before the child was born. If neither of these is the case, you as the mother have sole authority to apply.</li> </ul>

Kosten	<ul style="list-style-type: none"> <li>• Costs may be incurred for issuing a certificate of miscarriage.</li> </ul>
Verfahrensablauf	<ul style="list-style-type: none"> <li>• The registry office can issue a certificate of miscarriage to the notifying party on request.               <ul style="list-style-type: none"> <li>• The notification must be made verbally or in writing.</li> <li>• A certificate of miscarriage issued by a doctor, midwife or obstetrician is required for the full notification.</li> <li>• An identity card, passport or other recognized passport replacement document of the parents.</li> <li>• An indication of the intended surname and first name of the child.</li> <li>• The registry office issues the certificate on the basis of this information.</li> </ul> </li> </ul>
Bearbeitungsdauer	Usually issued immediately.
Frist	As a rule, there are no time limits worth mentioning, as this is a matter of the persons concerned coming to terms with their grief. As there is no notarization and the certificate has no legal effect, the deadlines for reporting a live birth, for example, do not apply here.
