Teaser	Do you have a professional qualification as a teacher from abroad and want to work in Schleswig-Holstein? Then you need to have your teaching qualification recognized.
Volltext	<p>Working as a teacher is regulated. This means that you must provide proof of a specific qualification if you want to work as a teacher in Schleswig-Holstein without any restrictions. You can apply for recognition of your foreign teaching qualification for this activity.</p> <p>In the recognition procedure, the competent authority compares your teaching qualification from abroad with the teaching qualification in Schleswig-Holstein. Your qualification must be equivalent for recognition.</p> <p>In addition to the equivalence of the professional qualification, you must meet further requirements in order to work as a teacher. You usually only have to prove these requirements when you are employed as a teacher. This is a different procedure.</p>

- Copy of proof of identity (passport or identity card)
- Copy of marriage certificate (if your name has changed due to marriage)
- Copies of university diplomas and/or certificates
- Proof of your professional qualifications (e.g. certificates, diplomas, professional certificate) in copy
- Proof of the content and duration of your education (e.g. diploma supplement, transcript of records, examination regulations) as a copy
- Proof of your other qualifications (e.g. further professional training, seminars) as a copy
- A copy of proof of your professional experience as a teacher
- Information about an application for recognition that has already been submitted. Please indicate the body to which you have submitted the application. If you have already received a notice of recognition from another federal state, please enclose a copy of it

The responsible office will tell you which documents you may have to present again in the original. Some copies must be officially certified. We recommend that you do not send originals by post.

You must submit your documents in German. The translations must be done by publicly appointed or authorized translators.

Other documents are usually important for employment in the teaching profession. You only have to submit these documents if you take a compensatory measure or if you are hired as a teacher.

- Proof of your German language skills: Language certificate at least C1 (C2 is recommended).
- Proof of your personal suitability:
Certificate of good conduct from Germany or your country of origin (for example, criminal record extract, Certificate of Good Standing).
- Proof of your health suitability: medical certificate

- You live in Schleswig-Holstein
- You want to work as a teacher in Schleswig-Holstein

You must fulfill further requirements for employment in the teaching profession:

- You have German language skills at the required level of the Common European Framework of Reference for Languages (CEFR). The responsible office will inform you of the required language level. German language skills at level C2 are recommended.
- Personal suitability: You are reliable to work as a teacher and have no criminal record.
- Health suitability: You are in good health.

In Schleswig-Holstein, the recognition procedure is free of charge. Additional costs may be incurred (e.g. for translations or notarization of your documents). These costs vary from person to person. You must pay these costs yourself.

Verfahrensablauf

You submit an application to the responsible office. You can send the application by post or electronically. The responsible office will inform you.

- The responsible office receives the application.
- It will confirm to you after a maximum of one month that the application has been received.
- Once the competent body has received all the documents from you, it will process your application.
- The competent authority will then examine it: Has your professional qualification been completed and is it equivalent to the professional qualification in Schleswig-Holstein? The competent authority will compare the qualifications using certain criteria. Important criteria are, for example, the duration of the training, the content of the training and the number of subjects taught.
- The competent body also takes your professional experience and your other certificates of competence into account when assessing equivalence.
- If your professional qualification and the

professional qualification in Schleswig-Holstein are equivalent, you will receive recognition.

Sometimes there are significant differences between the professional qualifications. If there are significant differences, you can usually take a compensation measure.

There are various compensation measures:

- Adaptation course: you work as a teacher and perhaps do additional training. This means, for example, that you take part in courses at a university. You already work at a school and receive further training.
- Aptitude test: You take teaching tests and oral examinations. A teaching sample means that you conduct lessons with pupils. Examiners observe and assess your lessons. The responsible office will inform you about the necessary teaching samples and examinations.

You can usually choose between an adaptation period or an aptitude test. The adaptation period is always recommended. The responsible office will inform you.

Once you have successfully completed the compensation measure, you will receive recognition.

With the recognition you can apply for the teaching profession in Schleswig-Holstein. This is a separate procedure. The other requirements for the so-called teaching qualification are then checked.

The teaching qualification is always valid for the teaching position applied for. This means that you can teach your subjects at a specific school. You have the same professional rights as a person with the Schleswig-Holstein teaching qualification.

	<p>The responsible office will confirm that your documents have arrived after a maximum of one month. Once the documents are complete, the procedure usually takes up to three months. Sometimes the competent authority may extend the procedure.</p>
Frist	<p>None. Sometimes documents are still missing from the procedure. The responsible office will then inform you by when you must submit the documents.</p>
