<b>Teaser</b>	If you want to carry out tests as a water testing body on behalf of the authorities or for self-monitoring or self-monitoring (e.g. as part of wastewater and raw water monitoring), you must apply for approval (notification).
<b>Volltext</b>	You can obtain approval as a water testing laboratory for the testing areas of wastewater, surface water, groundwater and untreated water.

HPLC methods,</li> <li>8\l. microbiological methods</li> </ul> <p>9.1 Biological methods, bioassays (part 1) and            9.2 Biological methods, bioassays (Part 2).</p> <p>Admission to an examination area requires proof of competence for sub-area 1 and for at least one other sub-area in this examination area. Competence must be demonstrated for at least 2/3 of the listed parameters of the respective sub-area. This criterion only applies to sub-areas with more than two parameters.</p> <p>A simplified approval procedure applies for the approval "Sampling in Schleswig-Holstein".</p>
Erforderliche Unterlagen	Please contact the responsible authority for the required documents, such as proof of premises, liability insurance, etc.
Voraussetzungen	The prerequisites relate to extensive requirements for the spatial and technical equipment as well as the number, expertise and reliability of the staff. These can be obtained from the competent authority.
Kosten	<p>for the authorization granted:</p> <p>Administrative fee 100 to 1000 EUR</p>

	Expenses: approximately 10 EUR
<b>Verfahrensablauf</b>	You submit an informal application with your signature and the required documents to the competent authority. In doing so, you name the area of investigation. The authority will check whether your application is complete and whether you meet the requirements. If you can be granted approval, it will be sent to you in writing. You will receive an invoice with the notification of approval.
<b>Bearbeitungsdauer</b>	Once all the required documents have been submitted, it will take an average of 4 weeks to process an application until a decision is made.
<b>Frist</b>	<ul style="list-style-type: none"> <li>• The authorization is granted for a maximum of five years</li> <li>• You must apply for the extension of the authorization at least six months before the authorization period expires</li> </ul>
