Teaser	You can extend your residence permit for the purpose of research before it expires if you wish to continue your work as a researcher in Germany.
Volltext	The residence permit for the purpose of research is a temporary residence title. You can apply for an extension of the residence permit for the purpose of research if you wish to continue your work at a German research institution beyond the period of validity of your residence permit.
	Apply for the extension of your residence permit at the Foreigners' Registration Office responsible for your place of residence at least eight weeks before the expiry of the time limit.
	The same requirements apply to the extension of the residence permit for the purpose of research as to its issue. In particular, you should be able to present a hosting agreement or a corresponding contract with a research institution.
	If you were obliged to attend an integration course when your residence permit was first issued, this will be taken into account when your residence permit is extended. If you have not yet taken part in an

	integration course, the Aliens' Registration Office may reject your application for an extension of your residence permit. If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete it or provide proof that you have been integrated into social life in some other way.
	In the case of an extension, your residence permit will be limited again. The residence permit for the purpose of research is extended for the duration of the research project.
	As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

Kosten	Extension of the residence permit for the purpose of research • for a further stay of up to three months: EUR 96 • for a further stay of more than three months: EUR 93
	Under certain conditions, a fee reduction or fee exemption may be considered.
Verfahrensablauf	<ul> <li>You must apply for the extension of your residence permit at the aliens' registration office responsible for your place of residence.</li> <li>Depending on the foreigners authority and your concerns, it may be possible to apply via the internet. Find out whether your foreigners authority offers electronic application for the residence permit.</li> <li>If the application is only possible in person, arrange an appointment with the Aliens' Registration Office.</li> <li>During the appointment, your application will be accepted and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuing of the electronic residence permit (eAT).</li> <li>In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment for an interview at the Aliens' Registration Office. During the appointment, your documents will be checked (please bring them shill be checked (please bring them shill be checked (please bring the appointment) office. 	• After about six to eight weeks, you can collect your eAT card from the Aliens' Registration Office.

	<ul> <li>Residence permits for the purpose of research may be extended if their period of validity is due to expire in the near future and the applicant intends to continue working at the research institution.</li> <li>The extension must be applied for at least eight weeks before the expiry of the time limit.</li> <li>An extension of the residence permit for the purpose of research is only possible if the prerequisites that existed when the permit was first issued continue to be met.</li> <li>In the course of the extension, the residence permit is again limited in time.</li> <li>If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that the obligation has been fulfilled. If the integration course has not yet been completed, the Aliens' Registration Office can refuse to extend the residence permit or can only extend it for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in some other way.</li> <li>An extension is excluded if this was already ruled out by the foreigners authority when the permit was issued or the last extension was granted.</li> <li>Depending on the Foreigners' Registration Office and the issue, the application can be made via the Internet or only in person.</li> <li>There are fees for the extension. The time as well as the form of payment varies depending on the authority responsible: Responsible: the foreigners authority responsible for the applicant's place of residence:</li> </ul>
