Teaser	You have successfully completed your studies in Germany and have already received a residence permit to look for a job.
Volltext	As a graduate of a German university, you have a legal right to be granted a residence permit for the purpose of seeking employment.  The residence permit will be issued for a maximum of 18 months directly following your studies. If this maximum period was not utilized when the permit was first issued, the residence permit can be extended accordingly. However, if you do not find a job during these 18 months, an extension is excluded and you are obliged to leave the Federal territory.  This residence permit allows unrestricted gainful

Erforderliche Unterlagen	<ul> <li>\- Valid national passport,</li> <li>\- Proof of secure livelihood (for example, employment contract and pay slips, bank statements, submission of a declaration of commitment by a third party),</li> <li>\- Proof of health insurance,</li> <li>\- Degree certificate, transcript or certificate from your university confirming the successful completion of your studies,</li> <li>\- 1 current biometric photo,</li> <li>\- Please inquire at the immigration office responsible for you whether you need to submit further documents.</li> </ul>
Voraussetzungen	You are in possession of a residence permit for the purpose of seeking employment after successfully completing your studies in Germany. The maximum period of 18 months has not yet been exhausted. In addition, you meet the general requirements for the issuance of a residence permit. These are in particular:  \- a secure livelihood \- a clarified identity \- possession of a valid national passport.
Kosten	Cost range: Fee: EUR 93.00 - 96.00
Verfahrensablauf	You can only apply for an extension of a residence permit in person at the Aliens' Registration Office responsible for your place of residence.  \- You submit the required documents in the original and pay the application fee. \- The Aliens' Registration Office will check whether the conditions for issuance are met. \- If all requirements are met, the Aliens' Registration Office will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH. \- As soon as the eAT is ready, it will be issued to you by the Aliens' Registration Office.
Bearbeitungsdauer	Approximately 5 to 6 weeks, depending on the workload at the local immigration office.
