Teaser	If you want to realize a research or development project in your company in Schleswig-Holstein, you can receive funding under certain conditions.
Volltext	<p>If you want to implement a research or development project in your company or together with other companies, your project may be eligible for funding.</p> <p>If you are planning an experimental development project in your company with the aim of developing new or improved marketable products, processes or services, your project may be eligible for funding. Funding also covers the transfer of technologies to a different production scale, for the adaptation of existing products, manufacturing processes or a product and service design to a different area of application, or for commercially viable prototypes and pilot projects.</p> <p>Complex research and development projects include research and development work that creates the technical and scientific prerequisites for the development of new future-oriented products, services or processes, new marketable products and services or new future-oriented procedures or processes.</p> <p>Preference is given to projects that contribute to climate protection or adaptation to climate change (resource, material and energy efficiency, circular</p>

The WTSH checks the application and requests any missing documents or information. Once a complete application has been submitted, the WTSH will decide whether to approve the funding.

If you would like to apply for funding for a complex research and development project, the application procedure is divided into two stages:

Stage 1 - Submission of project proposal

Project proposals can be submitted at any time by e-mail or post to the WTSH (Wirtschaftsförderung und Technologietransfer Schleswig-Holstein GmbH (WTSH), Lorentzendamm 24, 24103 Kiel). Before submitting a project proposal, it is recommended a consultation with the WTSH before submitting a project proposal. Both the project proposal and the subsequent application must be submitted before the start of the project and implementation may not begin without approval.

On the basis of the submitted project proposal and the project-related documents, a technical and, if necessary, market-related assessment is first carried out to determine whether the planned project is generally eligible and worthy of funding. The WTSH informs the submitting party in writing of the results of the assessment and, if the assessment is positive, recommends that the application be submitted.

Stage 2 - Submission of funding application (application)

In the second stage, a formal, complete funding application must be submitted online to the WTSH on the basis of the project proposal. An application must be submitted before the start of the project and implementation may not begin without approval.

There is no legal entitlement to funding. Instead, applications are checked for eligibility on the basis of selection criteria. These are described in section 4.1 of the guidelines and are as follows
