Teaser	If you are planning to convert underutilized or sealed areas into ecologically valuable areas, you can receive funding under certain conditions.
Volltext	If you are planning a land revitalization project in an urban area within Schleswig-Holstein, you can receive funding under certain conditions. Area revitalization means the preparation for the conversion of an underused or sealed area into an ecologically valuable area (e.g. green/park area, urban green, flowering/wild meadow, green infrastructure). The preparation for the conversion of an area for ecological reuse can also include the remediation of contaminated sites or the removal of soil contamination.

Voraussetzungen	• The project must not have been started yet. • The project should make contributions in the areas of equality, non-discrimination and sustainable development. • The overall financing of the project must be secured. • The project will generally be implemented in Schleswig-Holstein. • The project will be implemented in (sub)urban areas. • As the grant recipient, you must be a district or district-free city as well as a city, municipality, office or district-free municipality in the state of Schleswig-Holstein. • As the grant recipient, you must be fully responsible for ensuring that the project is carried out in compliance with funding law. • The eligible expenditure must amount to at least 200,000.00 euros. • The own contribution must amount to at least 10% of the eligible costs. • The grant amounts to up to 60% of the eligible expenditure. • If the land is sold within 10 years of the end of the project, proof must be provided of the conditions under which the sale was made. • You are bound to fulfill the conditions associated with the grant and the purpose of the grant for a certain period of time (earmarking). The implementation of the subsequent use described in the application must be proven within 5 years of completion of the funding project. • The earmarking of the subsequent use is up to 10 years.

Verfahrensablauf	You submit a funding application to Investitionsbank Schleswig-Holstein. It is recommended that you seek advice from Investitionsbank Schleswig-Holstein

	beforehand. Investitionsbank Schleswig-Holstein will check the application and request any missing documents or information. Once a complete application has been submitted, Investitionsbank Schleswig-Holstein will decide whether to approve the funding. There is no legal entitlement to funding. A project can only be started before the funding is approved if you apply for an early start of the measure and this is approved by Investitionsbank Schleswig-Holstein.
