Teaser	If you want to carry alarm, irritant and signal weapons with approval marks of the Physikalisch-Technische Bundesanstalt (PTB) in public, you must first apply for a small arms license.
Volltext	<p>If you have alarm, irritant and signal weapons with PTB approval marks in the district (so-called SRS weapons) outside of</p> <ul style="list-style-type: none"> <li>• your own home</li> <li>• your own business premises or</li> <li>• your own contented property (for example your own garden)</li> </ul> <p>you need a small firearms license for this purpose. However, carrying an SRS weapon at public events is generally prohibited.</p> <p>The small firearms license is not valid for compressed air weapons, spring-loaded weapons and CO2 weapons marked with an "F" symbol.</p> <p>It is recommended that you inform yourself in detail about the regulations of the weapons law before applying.</p>

	<p>If you are carrying an SRS weapon, you must have the small firearms license with you and be able to identify yourself with an ID card or passport.</p> <p>The small firearms license is valid indefinitely.</p> <p>You may be denied the small firearms license if you have not resided in Germany within the last 5 years.</p> <p>If you move to another city or municipality, you do not have to have the small firearms license rewritten.</p> <p>If you handle weapons and ammunition without a required weapons permit, you may face a fine or imprisonment.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Identity card or passport (copy)</li> </ul>
Voraussetzungen	<p>To obtain the small firearms license, you must be</p> <ul style="list-style-type: none"> <li>• be at least 18 years old</li> <li>• be reliable in terms of weapons law and</li> <li>• personal suitability</li> </ul> <p>possess.</p> <p><b>**Reliability under weapons law**</b></p> <p>You must be reliable under weapons law.</p> <p>You may be deemed unreliable under weapons law if, among other things</p> <ul style="list-style-type: none"> <li>• you have been legally sentenced to a prison term of at least one year within the last 10 years or have been a member of or supported a prohibited organization within the last 10 years.</li> <li>• it can be assumed that you misuse or improperly handle weapons or ammunition, do not store these items carefully or hand them over to persons who are not authorized to do so.</li> <li>• you have been in preventive police custody more than once in the last 5 years with judicial authorization</li> </ul>

	<p>due to violence.</p> <ul style="list-style-type: none"> <li>• You have repeatedly or grossly violated firearms laws.</li> </ul> <p><b>**Personal suitability**</b></p> <p>You must be personally suitable.</p> <p>You can be assessed as personally unsuitable if, among other things</p> <ul style="list-style-type: none"> <li>• You are legally incompetent.</li> <li>• You are addicted to alcohol or other intoxicating substances, are mentally ill or debilitated.</li> <li>• you suffer from serious illnesses, such as brain injuries, or physical impairments, such as amputations or severe visual impairment.</li> <li>• it can be assumed that you are not able to handle weapons or ammunition carefully or properly or that there is a concrete danger that you will endanger others or yourself.</li> </ul>

Verfahrensablauf	<p>You must apply for the small firearms license at the competent firearms authority. Submit the application together with the required documents.</p> <p>The firearms authority will issue the small firearms license if you meet the necessary requirements.</p>

issue

- Small firearms license for the concealed carrying of a permit-free firearm outside of
  - one's own home
  - one's own business premises
  - one's own contented property (e.g. garden)
  - a shooting range
- no carrying at public events
- Firearms that do not require a permit are
  - Firearms with which cartridge ammunition is fired (alarm firearms),
  - firearms that are used to shoot irritants or other substances (irritant weapons), or
  - firearms with which pyrotechnic ammunition is fired (signal weapons).
- Permit-free firearms marked with the approval mark "PTB"
- Transport of a permit-free firearm without the small arms license only if the weapon is
  - is not loaded (not ready to fire) and
  - is in a locked container (not ready for access)
- Carrying an unlicensed firearm only with
  - identity card or passport and
  - the small firearms license
- Permit is valid for an unlimited period
- Requirements:
  - Minimum age: 18 years
  - No previous convictions (reliability under weapons law)
  - No incapacity, mental illness or dependence on drugs (personal suitability)
  - Storage of the weapons in a locked container
  - In case of a move: no re-registration of the small firearms license necessary
- Responsible: Weapons authority
