Teaser	If you are in possession of a residence permit for employment (gainful employment) and would like to change employers, this is possible under certain conditions.
Volltext	If, as a foreign person, you are subject to the employment requirement for a certain type of employment or a certain employer, you can, under certain conditions, have this employment requirement changed when you change employer to another company. To do this, you must submit an application to the relevant immigration authority. In most cases, the result is dependent on the approval of the Federal

Verfahrensablauf	<ul style="list-style-type: none"> <li>• If you would like to apply for a change of employment of your residence permit, you must first submit an application for this to your competent immigration authority. Send a copy of your current residence permit with your application and describe which condition you would like to change and how.               <ul style="list-style-type: none"> <li>• The immigration authorities will then tell you which documents they need from you.</li> <li>• Then submit the requested documents in full to your immigration office.</li> <li>• The immigration office will then review your application and usually ask the Federal Employment Agency to approve it.</li> <li>• Once the review is complete, you will either receive an appointment, a new residence title by mail, or a notice of rejection.</li> </ul> </li> </ul>
Bearbeitungsdauer	1 to 3 months Note: The duration depends on the workload of the immigration office and the Federal Employment Agency.
Frist	There are no deadlines, however, you should consider applying for a new residence title if your old title is only valid for a few more months.

- Confirmation of the person giving the job that the training position has been taken up
- Form "Declaration of employment relationship job description
- Certificate of registration or tenancy agreement and confirmation of move-in from landlord
- If available: Certificate of recognition of professional qualification & proof of professional qualification
- If available: Admission agreement from the research institution
- For self-employed activities: Proof of funding for implementation
- Passport
- Requirements:
  - Main residence in the relevant competent place
  - Work permit is limited to one company and the company is to be changed
- Application
- Responsible: Foreigners authority or immigration authority
