Teaser	If you are active in mining with your company and would like to extend your permit to prospect for mineral resources, you can apply to the relevant Bauthority.
Volltext	A mining permit for the exploration of one or more mineral resources is initially granted for a maximum of 5 years. Once these 5 years have expired, you can extend the permit for a further 3 years under certain conditions. You must apply for such an extension. There are 3 types of mining permits: • Permit for commercial purposes: exclusive right to discover deposits and determine their extent, • Permit for scientific purposes: exclusively for research purposes and • Permission for large-scale exploration: to determine the characteristics of possible deposits. The exploration permit does not allow you to implement any technical measures, such as drilling or seismic surveys. The permit only allows you toexplore mineral resources in the permit field granted to you. A commercial permit for a specific mineral resource cannot be covered by another commercial permit for the same mineral resource at the same surface location. This does not apply to scientific and large-scale exploration of non-mining mineral resources, as the exploration objective is different here.

	The permit under mining law extends to so-called non-mining mineral resources, which are of special importance.r importance to the economy as a whole. These include energy resources such as hard coal and lignite or crude oil and natural gas, as well as precious and non-ferrous metals and salts. The area covered by the permit is limited to the earth's surface and theoretically extends to the center of the earth.
Erforderliche Unterlagen	 Proof of the original exploration permit Proof of the original work program with the following details: Period for which your permit was applied for Description of the work and the type of exploration financial expenditure original schedule for the exploration activities Proof that the permit field could not be sufficiently explored at the end of the permit despite the planned exploration.
Voraussetzungen	Certain requirements must be met before you can extend the permit: • You are the holder of an exploration permit. • The permit field could not be sufficiently investigated after the expiry of the permit despite planned exploration coordinated with the competent authority.

Kurztext	 Mining Permit Extension Grant Prior procedure for the exploration (prospecting) of certain (non-mining) raw materials (mineral resources) in a defined area (exploration field). defines an area in which only the holder of a permit has the right to explore the designated mineral resource A permit to explore for raw materials, also known as an exploration permit, is limited to 5 years The permit can be extended by 3 years Prerequisite: the permit field has not yet been sufficiently investigated despite planned exploration coordinated with the responsible authority Exploration permit refers to so-called non-mining mineral resources Can be issued for commercial exploration scientific exploration for large-scale exploration Application via online portal "BergPass" or directly to the responsible mining authority Responsible: Mining authority of the federal state in which the permit field is located
