Volltext	<p>If you would like to carry out a project to secure skilled workers in Schleswig-Holstein, you can receive funding with the help of a non-repayable grant for project financing as part of the Schleswig-Holstein Skilled Workers Initiative (FI.SH).</p> <p>Funding is available for projects to develop and test measures to secure skilled workers, particularly in the following areas</p> <ul style="list-style-type: none"> • Improving the matching of job supply and demand • Recruitment of skilled workers in so-called shortage occupations • Attracting skilled workers and employees from abroad • Strengthening the development of skilled workers for a climate-neutral economy • Regional skilled labor projects • Skilled worker networks for industries <p>The funding is granted as pro rata financing with a maximum amount and does not have to be repaid.</p> <p>The maximum amount of funding is 70 percent of expenditure.</p>

Personnel expenses are granted according to the actual expenditure principle and a lump sum of 40 percent.

- Expenditure and financing plan
- Required audit result (differentiation from the services offered by the BA and other responsible bodies.
- Any cooperation agreements to be submitted

The following documents must be submitted in addition to the application:

- Extract from the register of associations
- Proof of the person(s) authorized to represent the association (board of directors or management)

2. in the case of de minimis aid already received
