| Volltext                         | The profession of healthcare and nursing specialist is<br>regulated in Germany. This means that in order to<br>work as a healthcare and nursing professional in<br>Germany, you need a state license. With this permit,            |

you can use the job title "healthcare and nursing professional" and work in the profession. You can also apply for the job title "healthcare and nursing specialist".

You can also obtain a state permit from the competent authority in Germany with a professional qualification from a so-called third country. Third countries are all countries that do not belong to the European Union (EU), the European Economic Area (EEA) or Switzerland. In order to obtain the permit, you must have your foreign professional qualification recognized.

On January 1, 2020, nursing training in Germany was reformed and the new Nursing Professions Act came into force. The profession on this basis is called Pflegefachperson and is new. There is a transitional period for the recognition of foreign professional qualifications on the basis of the Nursing Act. Under certain circumstances, foreign professional qualifications can still be recognized as healthcare and nursing specialists on a transitional basis until 31 December 2024. The competent authority will advise you.

|                          | In the recognition procedure, the competent body<br>compares your professional qualification from abroad<br>with the German professional qualification and checks<br>the equivalence. The equivalence of the professional<br>qualification is an important prerequisite for the<br>granting of a state license. In addition to the<br>equivalence of the professional qualification, you must<br>also meet other requirements for the permit to be<br>issued. Further requirements include, for example,<br>sufficient German language skills and health suitability.<br>If your professional qualification originates from the<br>EU, the EEA or Switzerland, other regulations apply.<br>You can also apply for the procedure from abroad. |

• Marriage certificate (if your name has changed due to marriage)

- Curriculum vitae
- Proof of your professional qualifications (e.g. certificates, professional certificate)
- Proof of training

• Proof of your relevant professional experience in a profession comparable to healthcare and nursing

• Proof of other relevant knowledge for working as a healthcare and nursing professional

• Information about an application for recognition that has already been submitted. Then state the body to which you have submitted the application.

• Do you live or work in a third country, i.e. not in the EU, EEA or Switzerland? Then you may have to prove that you have received a commitment from a health and care institution to work as a nursing professional in Germany.

You usually submit these documents later. The responsible office will inform you when you should submit the documents:

• Proof of your personal suitability: criminal record extract or certificate of good conduct from your country of origin.

• Proof of your health suitability: Medical certificate.

• Proof of your German language skills: Language certificate

The responsible office will tell you which documents you need to submit as a simple copy, a certified copy or the original.

The professional<br>qualification is equivalent if there are no significant<br>differences between your professional qualification<br>and the German professional qualification. |

If your foreign professional qualification is equivalent, it will be recognized. The competent authority can confirm the result in writing. You must still meet the other requirements. You will then receive permission to use the professional title "healthcare and nursing specialist", "healthcare and nursing assistant" or "healthcare and nursing assistant".

Are there any significant differences between your professional qualification and the German professional qualification? You may be able to compensate for the differences through your professional experience, other knowledge or skills (lifelong learning). Knowledge and skills must be certified by an authority in the country in which you acquired the knowledge or skills.

However, it may be that the significant differences cannot be compensated for by your professional experience, knowledge or skills. In this case, the competent authority will tell you the main differences between your professional qualification and the German professional qualification and why you cannot compensate for the main differences.

The competent authority will also inform you of compensatory measures that you can take to offset the significant differences. If you decide not to take compensatory measures, your professional qualification will not be recognized and

you will not be allowed to work as a healthcare and nursing professional in Germany.

\*\*Compensatory measures\*\*

There are various compensation measures:

• Adaptation course: The adaptation course lasts a maximum of 3 years.

• Knowledge examination: The knowledge examination tests your knowledge in certain subjects and areas. The knowledge test comprises an oral and a practical part.
