Teaser	<p>If the holder of a mining permit dies, the right to the permit is transferred to the heirs.</p> <p>If a company becomes the universal successor of another company, the licenses are transferred to the new company.</p>
Volltext	<p>A mining permit, also known as an exploration permit, allows you to explore for certain raw materials in a specified area and for a specified period of time.</p> <p>If the holder of a mining permit dies, it is transferred to the heirs. Up to 10 years after the death, the right may also be exercised by the so-called beneficiaries. These are</p> <ul style="list-style-type: none"> <li>• Administrators of the estate</li> <li>• estate administrators</li> <li>• executors of the will.</li> </ul> <p>In both cases, you as the heir or person entitled to dispose of the estate must apply to the competent authority for a transfer of the license.</p> <p>In the event of the conversion of companies with accompanying universal succession, the transfer of the license to the new company must be reported immediately.</p>

Verfahrensablauf	<p>You can apply to transfer your permit online via the "BergPass" platform or in writing to your local mountain authority.</p> <p>Apply for a permit transfer online:</p> <ul style="list-style-type: none"> <li>• To register, you will need a BundID and an identity card or residence permit with an active online ID function.</li> <li>• Go to the "BergPass" online platform and log in.</li> <li>• Call up the application form and fill it out completely and truthfully.</li> <li>• Upload the required documents as a file and send the application.</li> </ul> <p>Apply in writing for the permit to be transferred:</p> <ul style="list-style-type: none"> <li>• Contact your responsible mining authority and coordinate the required application documents.</li> <li>• Submit the application and all required documents.</li> </ul> <p>Further procedural steps:</p> <ul style="list-style-type: none"> <li>• The competent authority will check your notification and the documents submitted. If any documents are missing, the authority will contact you.</li> <li>• You will receive a notification by post informing you of the decision on your application.
