Teaser	If you are a doctor and would like to apply for an authorization in accordance with the Compressed Air Ordinance, you can obtain this from the competent authority under certain conditions.
Volltext	As an authorized doctor, you have the task of carrying out initial examinations, re-examinations and assessments as well as special medical supervision. You keep a health record for each person who is subject to your medical supervision.

Voraussetzungen	• You can prove that you • have a license to practice medicine, • have the professional title of occupational medicine

Kosten	Gebühr: 100€ - 1.000€
Verfahrensablauf	You submit your application with the relevant documents and evidence to the competent authority. The authority will review the application and decide whether to grant the authorization in accordance with the Compressed Air Ordinance. If the review is positive, the authorization will be sent and the administrative fees will be charged.
Bearbeitungsdauer	The processing time depends on the completeness of the documents submitted.
Frist	5 Jahr(e) The authorization is granted for the requested medical examinations and other measures for five years or for the duration of the compressed air work to be carried out on a construction site. Upon application, the authorization can be extended for a further five years under certain conditions.
