Volltext	<p>Monument protection and monument preservation serve to research and preserve cultural monuments and monument areas. Monument protection refers to sovereign activities, while monument preservation refers to scientific and advisory activities.</p> <p>Cultural monuments are objects, groups of objects or parts of objects from the past whose research or preservation is in the public interest due to their special historical, scientific, artistic, urban planning, technical or cultural landscape value.</p> <p>The approval of the lower monument protection authority is required for</p> <ul style="list-style-type: none"> • the restoration, alteration and destruction of a cultural monument, • the transfer of a cultural monument of local historical or cultural landscape significance to another location, • the alteration of the surroundings of an immovable cultural monument if it is likely to impair its impression.
