Volltext	<p>The registration of a vehicle that has already been registered in the EU or EEA is possible upon application. The registration is issued by the responsible registration authority. If you buy a new or used vehicle abroad or move to Germany with a vehicle registered to you abroad, you must apply for registration for this vehicle.</p> <p>Registering a vehicle that was previously registered abroad is more time-consuming than registering a new vehicle or transferring a registration, as more documents are required.</p>

Further information can be obtained from your local registration authority.

Further documents if necessary, e.g:

- if you are represented by a third party: your written power of attorney and your identity document (original); the authorized representative must be able to identify himself/herself with a valid identity card/passport.
- if you are a minor: the written declaration of consent of the legal guardians and their identity documents (in the original); if applicable, a certificate of sole custody (so-called "negative certificate") for single parents

If you have vehicle tax arrears or arrears of fees and expenses from previous registration processes, the registration authority will refuse registration until you have paid these.

If someone is registering your vehicle on your behalf, the authorized representative must present a written power of attorney from you. This must also contain a
