Teaser	If you want to drive a passenger car up to 3,500 kilograms, you must apply for a class B driver's license.
Volltext	 With the class B driver's license, you can drive motor vehicles (motor vehicles) with a maximum permissible mass of 3.5 tons. The motor vehicle must also be designed for no more than eight people (in addition to the person driving). You can transport trailers weighing less than 750 kilograms with a Class B driver's license. If the total mass of the vehicle combination is not more than 3.5 tons, the trailer may also weigh more than 750 kilograms. The class B driver's license is issued for an unlimited
	 period of time. Anyone who wants to drive a motor vehicle on public roads in the Federal Republic of Germany needs a driver's license. The driving licence is issued in certain categories and must be proven by a driving licence. The requirements for obtaining a driving licence for the different categories of driving licence differ greatly. The licence shall be issued for the relevant category if the applicant: has his normal place of residence in Germany, has reached the required minimum age: 15 years for classes AM, 16 years for categories A1, T and L 17 years for classes B, BE 18 years for categories A2, B, BE, C1,

Kosten	 The fee is based on the Fee Regulations for Road Traffic Measures (GebOSt). If the driver's license is sent directly to the home address, an additional shipping fee will be charged.
Verfahrensablauf	The application for a driving licence must be submitted in writing to the driving licence authority. The driving licence authority examines the documents and determines whether there are any concerns about the applicant's suitability to drive motor vehicles. The driving licence is issued by handing over the driving licence. This is usually done by passing the practical driving test.

Frist	 12 Monat(e) Your application for an initial driver's license will be forfeited if you do not pass the theoretical test within 12 months of receiving the test order or if you do not pass the practical test within 12 months of passing the theoretical test. Driving licences of categories AM, A1, A2, A, B, BE, L and T are issued for an indefinite period. • Driving licences of categories C, CE, C1, C1E, D, D1, DE and D1E are issued for five years if appropriate proof of aptitude is available. The extension of classes D, D1, DE and D1E can only take place beyond the age of 50 if the applicant also proves that he or she meets the "special requirements".  Driving license issuance for the first time for class B Driving license class B allows driving motor vehicles (except motorcycles) up to 3,500 kilograms permissible total mass (zGM) with up to 8 seats (in addition to the seat of the person driving) also with trailer (zGM 750 kilograms) also with heavier trailer, provided that the combination does not exceed 3,500 kilograms responsible: competent driver licensing authority
To your district or independent city (driving licence authority). The responsibility depends on the place of residence (main residence according to the identity card).
