The rescue service is a public task of the districts and independent cities with the aim of ensuring that the population is provided with emergency rescue and ambulance services in a needs-based and efficient manner.

Emergency rescue: Emergency rescue comprises the medical care of emergency patients by specially qualified personnel and transportation in specially equipped ambulances to a treatment facility suitable for further care.

Patient transportation: Ambulance transport is the transportation of other sick, injured or needy persons who require specialist medical care or the special facilities of an ambulance during transportation or for whom this is to be expected due to their condition.

Air rescue: Air rescue supplements and supports the
