Teaser	A certificate of no impediment to marriage certifies that there are no legal obstacles to an intended marriage
Volltext	A certificate of no impediment to marriage certifies that there are no legal obstacles to an intended marriage. Whether such a certificate is required depends on the law of the country in which the marriage is to take place. If you are a foreigner wishing to marry in Germany, you must present a certificate of no impediment to marriage from the country of which you are a citizen. This is a requirement of German marriage law. In this certificate, the competent home authority must confirm that there is no legal impediment to marriage under your home law. Nationals of countries whose law does not require a certificate of no impediment to marriage require instead a formal exemption from the obligation to provide a certificate of no impediment to marriage. This exemption is granted by the President of the Higher Regional Court. If you are a German citizen wishing to marry abroad, please enquire with the competent foreign authority as to whether a certificate of no impediment to marriage is required there. The certificate is issued by the registry office of your German place of residence if there are no obstacles to the intended marriage under German law. Due to international treaties, especially with our immediate neighboring countries, there are some special features in this area about which your registry office can inform you.
