Teaser	Are you a single parent and receive no or only partial maintenance from the other parent? Then you can apply for an advance on maintenance payments under certain conditions.
Volltext	You will receive advance maintenance payments for your child if you are raising it in your household without another parent against whom the child is entitled to maintenance. However, this maintenance is not paid by the other parent or the person obliged to pay maintenance, or is paid incompletely or irregularly.
	The child's center of life must clearly be in your household. You must not have married a new partner.
	If the eligibility requirements are met, the maintenance advance will be paid to you until your child reaches the age of majority. The limit on the duration of receipt (previously a maximum of 72 months) has been lifted.
	The amount of the maintenance advance is calculated from the amount of the respective minimum maintenance rate less child benefit and, if applicable,

	less any maintenance payments or half-orphan's pensions already received.
	From 01.01.2025, the following amounts apply (minimum maintenance less child benefit):
	• EUR 227.00 per month for children up to 5 years of age
	<ul> <li>For children from 6 to 11 years EUR 299.00 per month</li> <li>For children aged 12 to 17 inclusive EUR 394.00 per month</li> </ul>
	After the age of 12, your child is only entitled to maintenance if one of the following conditions is met:
	<ul> <li>You or your child do not receive a citizen's allowance.</li> <li>Advance maintenance payments can prevent your</li> </ul>
	<ul> <li>child from needing assistance.</li> <li>You have a gross monthly income of at least EUR</li> <li>600.00 and receive supplementary citizen's allowance.</li> </ul>
	This ensures that, if necessary, all children receive maintenance advance without any gaps. At the same time, an important incentive is created for households that are not in need of assistance or could become independent of basic security benefits through their own earned income to secure their own livelihood.
	The maintenance advance is always paid at the beginning of a calendar month and can be applied for retroactively for one month.

Hinweise	The following information is available:
	<ul> <li>Children between the ages of 12 and 18 are only entitled to an advance on maintenance payments if the child is not dependent on SGB II benefits or if the single parent in receipt of SGB II benefits has a gross income of at least EUR 600.00.</li> <li>The other parent must repay the maintenance advance to the maintenance advance office. If the maintenance debtor does not pay, the maintenance advance office can sue for repayment and enforce it.</li> </ul>
