Teaser	An excerpt from the commercial register shows the current legal status of a company.
Volltext	An extract from the commercial register shows the current legal status of a company. In particular, the extract indicates who can legally represent the company. Various authorities and institutions (trade office, banks, etc.) therefore require an extract from the register. In addition, any interested party can inspect the commercial register or obtain an extract. A distinction must be made between an excerpt and a certified excerpt. You also have the option of simply inspecting the commercial register.
