Teaser	Anyone completing vocational training with an extended journeyman's examination requires separate admission for part 1 of the journeyman's examination.
Volltext	If you are completing vocational training with a "stretched journeyman's examination", you require separate admission for Part 1. In order to be admitted to Part 1 of the journeyman's examination, you must • have completed the required training period specified in the training regulations, • have provided proof of training, • register for the examination or have your trainer register you for the examination. In addition, your vocational training relationship must be entered in the apprenticeship register. This does not apply if the entry is missing for a reason for which neither the trainee (apprentice) nor their legal representative is responsible. The chairperson of the examination board decides on admission to the journeyman's examination. If he/she does not consider the admission requirements to be met, the examination board shall decide.

Hinweise	Trainees must be released from work to take examinations. Trainees will continue to receive their training allowance for the time they are released from work. People with disabilities should indicate their special needs when registering for the final examination so that these can be taken into account when the final examination is conducted. Trainees who have taken parental leave must not be disadvantaged by this when deciding on admission.
