| Volltext                      | <p>Anyone who collects, gathers or transports animal by-products on a commercial basis must notify the competent authority before commencing their activities (Section 7 of the Animal By-products Disposal Ordinance).</p> <p>For businesses or facilities in which animal by-products are temporarily stored (storage facilities), treated (intermediate treatment facilities), processed (processing facilities, fat processing facilities) or disposed of (incineration and co-incineration plants), prior approval is required (Articles 10-14 of EC Regulation No. 1774/2002).</p> <p>Exemptions are required for certain other uses of animal by-products (Section 4 of the Animal By-products Disposal Act).</p>                                                                                                                                                                                                                                                                                                                           |
