Verfahrensablauf	<ul> <li>You receive benefits for education and participation on application.</li> <li>If possible, find out in advance from the responsible office how you can apply for benefits from the education package most easily.</li> <li>The staff will also help you with the application on request.</li> <li>Fill in the required forms, sign the application and compile the necessary supporting documents.</li> <li>Send the complete application documents by post to the relevant office or hand them in personally.</li> <li>You will receive written notification as to whether your child is eligible for the program and, if so, which programs.</li> </ul>

Frist	Claims for benefits under the education and participation package in accordance with the Federal Child Benefit Act (for families with child supplement or housing benefit) expire 12 months after the end of the calendar month in which they arose.
