During questioning, they make sure, for example, that you do not give any information if you do not have to answer certain questions.</p> <p>If you, as a witness, are not in a position to exercise the powers to which you are entitled yourself due to special circumstances and your interests cannot be taken into account in any other way, you must be assigned a lawyer to assist you if you do not yet have a lawyer.</p>

Verfahrensablauf	<p>You must apply in writing to the competent authority for a lawyer to be assigned to you.</p> <p>The public prosecutor's office can also apply for this. The court can also assign a lawyer to you on its own initiative.</p>
