Voraussetzungen	 Registration in the Register of Skilled Crafts Proof of expertise If it is not possible to provide sufficient proof of expertise, you can prove the required knowledge and skills in an informal expertise examination. The examiner must be appointed by the competent Chamber of Skilled Crafts. You must bear the costs of the examination yourself.

Kosten	Costs may vary. Please enquire at the responsible Chamber of Crafts.
Verfahrensablauf	You must apply for the authorisation to practise in writing to the competent Chamber of Skilled Crafts. As a rule, you can also submit the application by e-mail. The Chambers of Skilled Crafts provide a form for this purpose, which you can download from the website of the competent Chamber of Skilled Crafts. If you wish, the Chamber of Skilled Crafts will hear the competent professional organisation.
