Some registry offices also offer the option of ordering certificates by fax, e-mail or telephone.</p> <p>In these cases, you must clarify with the registry office whether</p> <ul style="list-style-type: none"> <li>• it should send you the certificate or you should collect it and</li> <li>• how you can pay the fees (for example by bank transfer or in cash on collection).</li> </ul> <p>Some municipalities and cities also offer forms for electronic ordering on the Internet.</p> <p>You can also be represented when applying for or collecting the certificate.</p> <p>Please note Immediate issue of the certificate is not always possible.</p> |
