As a guardian, they have legal representation for a child in all matters.</p> |

| Verfahrensablauf | <p>As a foster parent, you can apply for guardianship or guardianship.</p> <p>You must then submit the application to the responsible local court (family court).</p> <p>The responsible youth welfare office will comment on the proceedings.</p> <p>The court decides who is appointed as guardian or carer, taking into account the best interests of the child.</p> <p>When the court decides on the change of custody, the following parties must be heard:</p> <ul style="list-style-type: none"> • the youth welfare office • the biological parents, if they still have custody rights • the child <p>Normally, the older the child is, the more important their opinion is.</p> <ul style="list-style-type: none"> • the foster parents |
