It is only valid for the duration of your employment.</p> <p>Please note: Driving licences issued from 19 January 2013 are limited to 15 years. However, the time limit only applies to the driving licence document. This must be renewed every 15 years. Regular medical examinations or other tests are not associated with the document exchange.</p> |
