	 the Technical Building Regulations (Administrative Regulation on Technical Building Regulations (VwV TB), a general building authority approval, a general building authority test certificate, the possible assignment of the construction product to Chapter D of the VwV TB, generally recognised rules of technology, a CE marking if the declared performance fulfils the requirements of the construction project or a European Technical Assessment (ETA).
	If the construction product cannot be assigned to any of the verifications 4 to 7 or if it deviates significantly from verifications 1 to 3, you need individual approval for the construction product.
	The following apply as proofs under building law for a type of construction
	 the Technical Building Regulations (VwV TB), a general type approval, a general building authority test certificate or a European Organisation for Technical Assessment (EOTA) Technical Report.
	If the type of construction cannot be assigned to Verification 4 or if it deviates significantly from Verifications 1 to 3, a project-related type approval is required for its application.
