Teaser	The eID card is a chip card with which you can prove your identity electronically. With the eID card, you can identify yourself online and, for example, carry out administrative or business transactions digitally.
Volltext	The eID card is a chip card with which you can prove your identity electronically. With the eID card, you can identify yourself online and, for example, carry out administrative or business transactions digitally. You can obtain the German eID card as a citizen of another member state of the European Union as well as Iceland, Liechtenstein or Norway (European Economic Area) - regardless of whether you live in Germany or not. The online ID function of the eID card offers you as a citizen of these states the same electronic function as the German electronic identity card or the electronic residence permit in Germany. You can apply for the eID card regardless of whether your home state has an eID system or not. If you use the eID card, you can decide and control yourself in each case whether and to whom you transmit personal data digitally. Validity of the eID card: 10 years
Erforderliche Unterlagen	 ID card (identity card), passport or another valid identity document issued by your home country If you do not have a residence in Germany, other proof of your residence is required. You can ask for the necessary documents at the competent mission abroad. If you have moved to Germany and have not yet registered, you must first register at a German registration office (usually: Bürgeramt). You can find

Voraussetzungen	You are
	 at least 16 years old and A citizen of another state of the European Union, or A citizen of another state of the European Economic Area.
Kosten	Issue of the eID card: EUR 37.00if the PIN letter is sent abroad: respective expenses
Verfahrensablauf	You can apply for the elD card in person at the competent office.
	 Contact your citizens' registration office and make an appointment if necessary.
	If you want to apply for your eID card outside Germany:
	 Contact the Foreign Office and the foreign mission in the district where you live.
Bearbeitungsdauer	about three to six weeks
Frist	Recommendation: Apply for a new eID card two months before it expires.

Hinweise	You are obliged to present the following to the competent authority without delay
	1. present the eID card if an entry is incorrect,
	2. hand over the old eID card when receiving a new eID card, and
	3. report the loss of the eID card and its recovery.
Rechtsbehelf	You can lodge an appeal against a negative decision. You will find the responsible office in the instructions on appealing the decision.
