<b>Volltext</b>	<p>In Baden-Württemberg, there are women's and children's shelters that offer women and their children temporary protection, accommodation and care if they are exposed to or threatened by domestic violence.</p> <p>The women's and children's shelters are supported by the state of Baden-Württemberg by funding measures for prevention, crisis intervention and aftercare as well as investment to provide counselling, support and protection services. They should also be available by telephone at all times in the event of emergencies and be ready to accept victims.</p>
<b>Erforderliche Unterlagen</b>	For investment funding: List of planned expenditure with details and explanations of the individual planned measures (informal).
<b>Voraussetzungen</b>	You are either a provider of a women's and children's shelter yourself. Or you are a charitable foundation, municipality/district, charitable organization or non-profit association and the requested grant will directly benefit a women's and children's shelter.

The grant notification will be sent electronically by e-mail or delivered to your service-bw mailbox.</li> <li>• You can then apply for the funding request (payment of the funding amount) in full or in instalments by e-mail directly to the responsible regional council and receive the transfer.</li> <li>• The proof of use must be signed and submitted by e-mail to the responsible regional council by 31 March of the following year.</li> </ul> <p>Further information and advice can be obtained from the responsible regional council.</p>
