Voraussetzungen	You have completed a course of training giving direct access to the profession of European lawyer.
Kosten	The fees depend on your personal case.
Verfahrensablauf	Make an application to the Judicial Examination Office. The Judicial Examination Office checks whether you have acquired all the knowledge and skills required to

work as a lawyer in Germany during your training. In this case, your degree will be recognised. If there are differences, you will have to take an aptitude test. The aptitude test consists of a written and an oral part. The written part of the examination consists of two papers. The oral examination consists of a short lecture and a discussion. The Examinations Office issues a confirmation of successful completion of the qualifying examination. A failed aptitude test may be repeated twice.
