Verfahrensablauf	<p>The nationwide standardised web application KaVKA-42.BV is available for operators to fulfil their information obligations.</p> <p>The use of the KaVKA-42.BV web application is mandatory in Baden-Württemberg for all notification obligations under § 13 and for all information obligations under § 10 of the 42nd BImSchV. In addition, the web application can be used for notifications under § 14.</p>

Frist	If a measure value is exceeded, you are obliged, among other things, to inform the competent authority immediately in accordance with Annex 3 Part 1 and within a period of 4 weeks in accordance with Annex 3 Part 2.
