Verfahrensablauf	• Continuous measurements are specified by the authorities in the authorisation notice for your system. • You analyse the continuous measurements of each calendar year. • You prepare a measurement report on the results. • You send the measurement report to the immission control authority responsible for you by the deadline.

Frist	• You must submit the measurement report for a calendar year to the responsible immission control authority within the period specified in the authorisation notice for your installation. • You must keep the measurement report and the records of the measuring devices for at least 5 years after the end of the respective reporting period.
