Volltext	Strict requirements apply to the travel of pets such as dogs, cats and ferrets. The aim is to avoid the introduction of rabies. It is therefore important that you
	<ul> <li>thoroughly inform yourself about the existing regulations of the various countries of travel before you start your journey and</li> <li>also think about re-entry into Germany.</li> </ul>
	Animals that do not comply with the required regulations must be
	<ul> <li>returned to the country of origin at the expense of the owner who imports them, or</li> <li>be placed in official quarantine, usually in an animal shelter, for the duration of any measures ordered.</li> </ul>
	In the case of a suspected disease, even killing is permissible.
	The requirements for travelling and returning with pets depend on the respective country of travel.
	A distinction is made between
	<ul> <li>Travel within the European Union,</li> <li>Import of animals from listed third countries and</li> <li>Import of animals from non-listed third countries.</li> </ul>
	As a rule, you will need for your pet
	<ul> <li>effective rabies vaccination. Vaccination is possible for pets at the earliest at the age of 12 weeks.</li> </ul>

	<ul> <li>Pet passport (with proof of rabies vaccination)</li> <li>Identification by electronic transponderUntil July</li> <li>2011, identification by tattoo was permitted .This is still recognised for animals marked before this date.</li> <li>Proof of the effectiveness of the rabies vaccination by determination of the vaccination titre (only for entry, also re-entry from non-listed third countries)</li> <li>Observance of a waiting period of three months after vaccination titre determination before entry from non-listed third countries</li> <li>Note: Further information on the requirements for importing pets into third countries (non-EU countries) must be obtained from the respective embassy in good time before travelling. For example, some countries require additional treatment against certain parasites.</li> </ul>
Erforderliche Unterlagen	<ul> <li>EU pet passport or analogous document proving rabies vaccination</li> <li>if applicable, official veterinary certificate and proof of rabies vaccination titre determination</li> </ul>
Voraussetzungen	<ul> <li>When travelling, the animals concerned must be accompanied by their owners or an authorised person.</li> <li>The animals must not be intended for sale or for a transfer of ownership.</li> <li>Maximum of 5 pets per person.</li> <li>Minimum age of dogs and cats travelling within the EU and from listed third countries is 15 weeks. For entry from non-listed third countries, the following times are added for the rabies vaccination titer determination and the waiting period.</li> <li>Entry for air travel via Border control posts or listed entry checkpoints (in Baden-Württemberg only Stuttgart Airport as a listed entry checkpoint).</li> </ul>

Verfahrensablauf	When travelling by air, you can only enter Baden-Württemberg by plane with your pet via the entry control point at Stuttgart Airport.
