	Note: The information provides data on business registration or re-registration. They are not checked for accuracy or completeness by the responsible office.

	If you wish to receive further data, you must demonstrate a legal interest.
	You have a legal interest, for example, if you
	 Wish to assert legal claims or refer to services provided by the business operator orservices provided or Grant loans to the traders.
	Please note: The trade register is not a public register such as the commercial register, register of co-operatives or register of associations. You therefore have no legal right to be informed of the data. It is at the discretion of the competent authority whether to provide you with the information.
Kosten	The costs are based on the municipal fee statutes. Please enquire at the responsible office.
Verfahrensablauf	You can request information from the trade register informally from the responsible office. In addition to your personal details, you should provide the data you know about the business you are looking for, e.:
