The data will then not be passed on.</p>
Erforderliche Unterlagen	<p>The municipality may request the following documents:</p> <ul style="list-style-type: none"> • Identity card or passport • in the case of a written application: Copy of passport or identity card
Voraussetzungen	It is a party, electoral group or other bearer of election proposals.
Kosten	<p>The costs for group information depend on the individual case.</p> <p>There are no fees or costs for the objection.</p>
Verfahrensablauf	<p>Parties, electoral groups and other sponsors of election proposals must apply for group information in writing to the competent office.</p> <p>Note: As the person concerned, you can lodge an objection to the granting of group information in writing or in person with the municipality.</p>
