	cooperatives), you only need to complete the application form for the legal entity itself. You must submit all personal documents for all natural persons authorised to manage the company (e.g. personal papers).
Voraussetzungen	You do not need any proof of qualification. This is different from a craft that is subject to registration in the register of crafts.
Kosten	Costs may vary. Please enquire at the responsible Chamber of Crafts.
Verfahrensablauf	You must register an unlicensed trade or a trade similar to a trade with the competent authority. Depending on what the Chambers of Crafts offer, the application form is available for download or can be filled out directly via a form centre. You can also submit your documents in person and fill out the application on site.
