	<ul> <li>Recognized and valid passport replacement document</li> <li>when moving into a rented property: confirmation from the landlord or corresponding allocation feature</li> <li>if moving into residential property: notarized purchase contract or extract from the land register</li> <li>for persons under guardianship: written power of attorney or guardian's certificate</li> <li>if represented by another person: written power of attorney and identification documents of the person to be registered, if applicable</li> <li>if moving from abroad: last residential address in Germany</li> <li>for spouses, life partners and family members with the same move dates: Date of moving in as well as previous and current residences.</li> <li>The competent authority may request the submission of further documents to verify the information (e.g.: marriage certificate, birth certificate).</li> </ul>
Voraussetzungen	• You have moved into another residence in Germany in addition to your main residence.
	<ul> <li>The following requirements apply to the online service:</li> <li>You are of legal age.</li> <li>You are not married and do not have a registered civil partnership.</li> <li>You are moving into your new home without underage children.</li> <li>You have a valid ID card or a valid eID card with activated online ID function and personal identification number (PIN).</li> <li>You have an NFC-enabled smartphone or a USB card reader.</li> <li>You have installed the ID card app2 on your smartphone.</li> <li>You have an M-V user account.</li> </ul>
Kosten	free of charge
Verfahrensablauf	You appear in person at the registration office responsible for you or are represented by a person

	with power of attorney if necessary:
	<ul> <li>You confirm by signature that the personal data requested by the registration authority from the previous competent registration authority is correct.</li> <li>You submit all the necessary documents.</li> <li>Finally, you will receive an official confirmation of registration of your new secondary residence from the registration authority.</li> </ul>
	For electronic residence registration:
	<ul> <li>You call up the online service.</li> <li>You log in to the online service with your user account.</li> <li>You enter all the required data online and submit the form online.</li> <li>You will receive a code by post to the address of your new secondary residence.</li> <li>You confirm your move into your new secondary residence by entering the code in the online service.</li> </ul>
Bearbeitungsdauer	The processing time is just a few minutes.
Frist	You must register your new secondary residence within 2 weeks of moving into the apartment.
