Volltext	<p>The costs for waste collection, disposal and other services are passed on to the landowner/tenant/user by means of a waste disposal fee notice issued by the respective district/city.</p> <p>The amount of the fee is calculated in accordance with the relevant waste disposal statutes and the waste fee statutes of your district/city.</p>
Erforderliche Unterlagen	
Voraussetzungen	Information from the public waste disposal authorities as to whether citizens are obliged to provide their own waste containers.
Kosten	There is no standardized nationwide fee regulation for waste disposal. The amount of waste disposal fees is determined by the waste disposal fee statutes adopted by the district or municipal parliament.
Verfahrensablauf	The waste disposal fee is set by the public waste disposal authority by means of a fee notice.

Frist	The deadline for payment varies depending on the waste fee statutes.
